The final decision will be made only after the end of this key negotiation phase expected to be completed by the end of January 2025.

During this process, GL events is committed to ensuring a successful outcome to these negotiations, with the goal of transforming the Stade de France into a genuine events destination, in coordination with sports federations and local authorities.

"The start of exclusive negotiations for the Stade de France concession marks a new phase that demonstrates the quality of the work accomplished by our teams.
